## JEAN-MICHEL SALIBA (MODERATOR) BofA Securities

Jean-Michel Saliba is a Managing Director, Head of Emerging Europe, Middle East and Africa (EEMEA) and Middle East – North Africa (MENA) region economist at Bank of America (BofA Global Research).
