RAMIRO BLAZQUEZ (MODERATOR) **BancTrust**



As President of the Central Bank of Venezuela in the early 1990s, Ms. Krivoy was instrumental in establishing the central bank's independence. In addition to her tenure at the Central Bank, Ms. Krivoy participated in pivotal processes including foreign debt restructuring negotiations in the late 1980s, state reform, fiscal reform and industrial competitiveness. She advises multilateral institutions and governments on financial sector reform and crisis management. She served as Vice-Chair and member of the Bank Advisory Board of the Toronto Center for Global Leadership in Financial Supervision.
